Failure by the parties to complete mediation within the required time-frame, unless excused or extended in writing by this Court, may result in dismissal of the action without prejudice; and
6. any other pertinent scheduling considerations or particular courtroom requirements.

Plaintiff's counsel **must report** on such matters to Staff Attorney, Lisa K. In cases involving a self-represented plaintiff, the plaintiff and defendant's counsel must report.

THERE WILL BE **NO** CONTINUANCES FROM THIS CALENDAR, EXCEPT FOR LEGAL CAUSE. **ONLY** JUDGE EDLEIN CAN CONTINUE A CASE FROM THIS CALENDAR. All requests for continuances must be in writing.

There will not be a CIVIL JURY Calendar call. Counsel in the first case to be tried will be notified by the Court. CASES WILL NOT NECESSARILY BE TRIED IN THE ORDER THEY ARE PUBLISHED.
