The consolidated pre-trial Order shall follow the format and substance set forth in Uniform Rule 7.1. Failure of any party to participate in a consolidated pre-trial Order and to submit same in a timely manner may result in dismissal, the exclusion of evidence, or other sanctions.

Requested jury charges must be e-mailed to the Court's Staff Attorney in Word format on the day the case is called for trial. Parties will be limited to fifteen (15) requests to charge, excluding any pattern requests, absent good cause shown.
