NOTICE OF JUDGE DIXON'S FEBRUARY 2022
CIVIL JURY TRIAL CALENDAR

All cases previously scheduled for Judge Dixon's January 7, 2022, Jury Trial Calendar Call/ January 11, 2022, Jury Trial Calendar have been **automatically re-set for the Court's Tuesday February 7, 2022, Zoom Virtual Jury Trial Calendar-Call/ February 8, 2022, Jury Trial. APPEARANCE at the calendar-call is mandatory. The Zoom information is attached (it is the same Zoom link used for Judge Dixon's January 7, 2022, virtual jury trial calendar-call).**

The following cases will be tried during a four (4) week period beginning **February 8, 2022**, and ending on **March 4, 2022**. There will be a **Zoom calendar-call/pre-trial conference on Monday, February 7, 2022 at 10:30 am**: attorneys appearing must be the attorneys trying the case or another attorney of record authorized to define the issues and enter into stipulations. **All parties should be prepared to argue their pre-trial motions and motions *in limine* virtually on February 7, 2022, at the conclusion of the calendar-call.**

Voir Dire/Jury Selection will occur on Tuesday, February 8, 2022, with jurors being virtual on Zoom, and all attorneys, in person, in courtroom 3A at the Fulton County Courthouse. Details about the logistics of the virtual voir dire will be provided to the parties at least three (3) days prior to the beginning of their trial.

Cases are listed in numeric order and NOT in the order that they will be called for trial. All cases will remain on two-hour notice/call throughout the remainder of the calendar. This is a continuing calendar; all cases that are not reached will be carried over to the March 9, 2022, calendar and every calendar thereafter until they are reached.

All parties are required to submit **Requests to Charge** (limit 15 for non-pattern charges) via Microsoft Word **and a Consolidated PreTrial Order** (the Court will not accept PreTrial Orders from each party separately) via email **no later than 4:00 p.m. on February 1, 2022,¹ to Mrs. Ottrell Edwards (ottrell.edwards@fultoncountyga.gov) the Court's Staff Attorney. Please send the full text of each of the charges you are requesting and not merely the charge number.** Also, please ensure you are using current pattern charges. Please review the calendar and inform Staff Attorney Edwards of any

corrections needed to the names of parties and associated counsel that will appear for the call of the calendar. Also, note that any corrections to the listed names should also be updated with the Clerk's office.

IF PRETRIAL ORDERS AND REQUESTS TO CHARGE HAVE BEEN PREVIOUSLY SUBMITTED, IT WILL NOT BE NECESSARY TO SUBMIT ADDITIONAL ONES.

If you are a Plaintiff, a failure to report and appear at the calendar call **may** result in your case being **DISMISSED FOR WANT OF PROSECUTION**. If you are a Defendant, a failure to report and appear at the calendar call **may** result in the entry of a default judgment. **In addition, if Defendant fails to appear, Plaintiff may be allowed to present evidence of damages and a final judgment may be entered as to damages.** If the Defendant has a counterclaim, a failure to report and appear at the calendar call **may** result in your counterclaim being dismissed for want of prosecution.

If your case is called to trial and you are not ready to proceed, your case will be **DISMISSED FOR WANT OF PROSECUTION**.

There will be no continuances granted except for statutory grounds. All conflicts and requests for continuances must be in writing and in this office by **February 1, 2022**.

DURING THE COURT'S FOUR-WEEK CALENDAR, PLEASE DO NOT CALL OR EMAIL CHAMBERS TO FIND OUT WHEN YOUR CASE IS GOING OUT. YOU WILL BE GIVEN SUFFICIENT NOTICE BEFORE YOUR CASE IS SET FOR TRIAL. THE COURT WILL NOTIFY PARTIES WHEN A CASE IS CALLED FOR TRIAL.
