**TRIALS WILL BE HELD VIA ZOOM CONFERENCE. PARTIES WILL BE NOTIFIED OF THE DATE/TIME OF TRIAL IN THEIR CASE VIA EMAIL FROM THE COURT TO THE EMAIL ADDRESSES LISTED IN THE JOINT WRITTEN REPORT.**

**SERVICE:** Service upon all defendants must be perfected no later than Tuesday, March 22, 2022 with **WRITTEN PROOF OF SERVICE** efiled and emailed to the Court at [ritu.bahri@fultoncountyga.gov](mailto:ritu.bahri@fultoncountyga.gov) no later than Wednesday, March 23, 2022. The Court will not grant any resets other than for legal cause. Failure to do so will subject the case to immediate dismissal without prejudice.

**BENCH TRIAL CASES:**

Attorneys and pro se parties shall submit a **JOINT WRITTEN REPORT no later than March 23, 2022** via email to [ritu.bahri@fultoncountyga.gov](mailto:ritu.bahri@fultoncountyga.gov) with the case status and shall include the following information:

1. Attorney names and parties represented;
2. Contact information for any pro se parties;
3. Expected length of trial;
4. **MOTIONS:** Whether there any motions pending that require a ruling, and if so, indicate the title of the motion and the date it was filed.

5. **DEFAULT LIQUIDATED:** For cases in **DEFAULT** with **liquidated damages**, Plaintiff must file a Motion for Default Judgment no later than **Wednesday, March 23, 2022**. In that event, a copy Motion for Default Judgment shall be sent to the Court via email listed above.
6. **DEFAULT UNLIQUIDATED:** For cases in **DEFAULT** with **unliquidated damages**, Plaintiff must file a Motion for Default Judgment as to liability and request a hearing for damages therein no later than **Wednesday, March 23, 2022**. In that event, a copy Motion for Default Judgment shall be sent to the Court via email listed above.

**FAILURE TO TIMELY SUBMIT A WRITTEN REPORT SHALL RESULT IN THE DISMISSAL OF THE COMPLAINT OR THE STRIKING OF THE ANSWER AND THE ENTRY OF JUDGMENT BY DEFAULT.**

The parties are reminded of Rule 22: “Use of Recording Devices & Cell Phones” which provides as follows:

Parties participating in remote proceedings and persons viewing live streams of such proceedings are reminded of the prohibition against photographing, recording, and rebroadcasting court proceedings. Uniform Superior Court Rule 22(C)-(D). Any recording of a court proceeding held by video or teleconference, including “screen-shots” or other visual copying is prohibited absent prior approval of the judge presiding over the proceeding.
